I also have extensive field and management experience dealing with water main and hydrant installations, drainage and gravity sewer lines and service lateral inspection and performed all data base entries and office functions to administer the Miami-Dade County I-E-I Program for the Water & Sewer Department and for The City of Fort Lauderdale Water Works.
